

# TIMBER HARVESTING BMP INSPECTION TEMPLATE

It is a requirement of 25 PA Code §102.4(b)(5)(x) that a maintenance program be conducted to provide for the operation and maintenance of all BMPs to be inspected on a weekly basis and after each stormwater event. The program must provide for completion of a written report documenting each inspection, and all BMP repair, or replacement and maintenance activities. This optional template is being provided as an acceptable standard format for written BMP inspection reports on non-permitted timber harvesting operations. Sites that require an Erosion & Sedimentation Control Permit (25 acres or more of earth disturbance) will need to use a different inspection form. Contact the Department or conservation district if you have any questions or concerns.
